#### 1- INTRODUCTION

In 1430H/ 2009, the Department of English Language (DEL) came about as the result of the re-structuring of the College of Education at King Faisal University. Within the College of Education, for twenty-five years the department operated under the name of the Department of Foreign Languages, and naturally focused on pedagogical issues and teaching English in Arabic context.

The new department, The Department of English Language, which is now part of the College of Arts, has shifted its focus to new areas of research. The shift has two main implications. The Department is open to a wide variety of branches and areas in English Language and Linguistics. It can also home more students with different interests. The M.A. program focuses on English Language and issues related to English in the local context, which will naturally lay the foundation for a better understanding of English and Arabic Islamic cultures, and which will contribute to enhancing positive dialogue between the two.

#### 2- BACKGROUND

Thousands of students graduated from the Department of Foreign Languages within the College of Education. The expansion in Higher Education in the Kingdom of Saudi Arabia does necessarily lead to a parallel expansion in programs of graduate studies. In this context, the M.A. in English and Linguistics offers opportunities for learning and research in English language and issues related to English in local context. The new program keeps pace with the shift from purely pedagogical concerns to wider issues of English language, translation and linguistic applications.

The new English Language Department has a prosperous outlook in its new environment of the College of Arts, in which it can collaborate with the departments of Arabic, Sociology, History and Media Studies. The department has a deeply-rooted experience in teaching English cultivating research. Currently it has a number of specialists in English Language and Linguistics:

- 1- Two professors
- 2- Four associate professors
- 3- Six Assistant professors
- 4- Twelve staff members doing research (Master and Ph.D. degrees) in Saudi Arabia, Britain, The United States and Australia.

# To Be a World Class Research Based Excellence Academic Program in English Language and Linguistics

# 4- MISSION

To train and produce highly qualified scholars of English language and Linguistics and to produce excellent research by applying knowledge to investigate English-related issues.

# **5- Program Rationale**

The Department of English Language has successfully run an M.A. Program entitled Applied Linguistics (Teaching English as a Foreign Language). The pedagogical overtone of that program cannot be missed, a fact which reflects the history of the department as it operated within the College of Education. The old program is still needed, but the present program operates in a different context and has a wider appeal. The reasons for offering the M.A. in English Language and Linguistics include the following:

- 1- There is a need to widen the scope of study and the expertise covered by the graduate programs offered by the DEL.
- 2- There is a need to address English language issues outside pedagogical concerns.

- 3- There is a need to keep abreast with the changes of the academic environment in the new College of Arts.
- 4- There is a need to prepare graduates who are tuned to the needs of society and local job market.
- 5- There is a need to encourage researchers in the DEL, and to offer opportunities to scholars who would like to study English at home.

# 6- OBJECTIVES

The objectives of the new M.A. program are based on the objectives of the new Department of English Language in the newly established College of Arts. The emphasis is mainly on advancing knowledge of English language and English research culture. The students are expected to have knowledge and training in:

- 1- Advanced knowledge of various theories and background of the main branches of English Language and Linguistics.
- 2- Content-related areas addressing issues and all applied studies including Corpus Linguistics, Forensic Linguistics, Language Learning, Evaluation and Language Planning and Translation.
- 3- Research in areas related to the knowledge domains of the program addressing locally-relevant issues.

## 7- ACADEMIC PROGRAMS CONSULTED

The plan has made use of standards and practices adopted and advocated in a number of institutional bodies. This main thrust of the program, however, reflects King Faisal University orientation and expansion of educational opportunities to a wider pool of learners and a wider range of specializations. In particular, the alignment with international academic institutions is seen in offering courses which focus

on areas in the fields which have direct relevance to English language in Arabic context in the Middle East. These areas include 1) English language and Core linguistics, 2) Translation, 3) Language Varieties, Corpus Linguistics, and Lexicology and Lexicography. In this sense, the program combines rigorous descriptive power and investigation of various local manifestations of English-related issues. The institutions consulted include the following.

- 1- *Unified Regulations on Graduate Studies in Saudi Universities*, Council of Higher Education.
- 2- King Faisal University Decrees and Decisions on Graduate Studies.
- 3- The Saudi Commission for Academic Assessment and Accreditation.
- 4- The newly developed B.A. program currently taught at the Department of English Language, College of Arts, King Faisal University.
- 5- The M.A. program in Applied Linguistics which has been offered to students for the last fifteen years by the Department of Foreign Language (Now re-named Department of English Language).

#### 8- ADMISSION

The requirements for admission to the M.A in English Language and Linguistics are derived from KFU admission procedures, including:

- 1. A Bachelor of Arts in English from King Faisal University with a C (Very Good, 3.75 out of 5) GPA at least, or an equivalent degree from another university with a B in major English courses.
- 2. Applicants should have studied the following prerequisite courses in their undergraduate program. When all or some of these courses are not covered, they should be studied by the candidates in the department's B.A. program prior to the commencement of the M.A. program.
  - Research Seminar/Project in English language.
  - Syntax
  - Phonology
  - Semantics
- 3- Applicants should pass one of the following tests:
  - a. TOEFL: achieving a score of 75 out 120, with a writing component (Taken within at most two years prior to the date of M.A. screening by the DEL)..
  - b. IELTS: achieving a score of 5.5 out of 9, with a writing component (Taken within at most two years prior to the date of M.A. screening by the DEL)..
  - c. Department admission test: achieving a score of 70, including a writing component).

#### 9- GRADUATION REQUIREMENTS

The following are necessary requirements for a successful completion of program.

- 1- Successfully complete 30 credit hours of course work. With a General Point Average of B (very good).
  - a. 14 hours of core courses.
  - b. 6 credit hours from elective courses Group A.
  - c. 4 credit hours from elective courses Group B.
  - d. 6 credit hours for thesis.
- 2- Pass a comprehensive examination, subject to completion of all core courses.
- 3- Write a thesis (20.000 words) about a topic within the domains of the program (6 credit hours for the thesis).

#### **10- STAKEHOLDERS**

Four main stakeholders are served by the M.A. Program in English Language and Linguistics: (1) local community, (2) program takers, (3) employers, (4) the research community in KFU. The program also stands to contribute to enhancing the availability of qualified cultivated specialists.

## 11- Students and the Learning Environment

The learning environment initiates and forms the learning experience students come to know and live in the program. It remains with each student. Therefore, the DEL works hard to make students' stay in the department both enriching and enjoyable.

The main link between the department and university on the one hand and the student on the program on the other, is the department Graduate Committee. Its responsibilities and services include:

- To ensure that academic standards and university regulations are upheld.
- 2- To carry out screening of new candidates giving equal opportunity to each student.
- 3- To make recommendation to the department based on the results of the screening.
- 4- To prepare schedules and recommend possible instructors.
- 5- To provide students with information about university regulations, facilities, program structure at different stages of the program especially in the first semester.
- 6- To monitor students' performance and advise those facing difficulty.
- 7- To keep program archives and files.
- 8- To receive students' complaints and assist in finding solutions.
- 9- To hold regular meetings with students.
- 10- To help in the formation of the viva voce committee.
- 11- To carry out tasks assigned to it by the chairman of the department.

# 12- Program graduates

The expected program graduates will be able to take up employment in various areas including the following:

- 1- Local professionals in English.
  - A. Educational supervisors.
  - B. Qualified experts.
  - C. Editors/writers in local media.
- 2- Potential researchers
  - A. College/university lecturers.
  - B. Private higher education institutions.
- 3- Privately employed
  - A. Self-employed
  - B. Collaborators with private businesses.

- 2- English Language: Grammar, Phonology, and various varieties of English.

Theoretical Advances in English Language and Linguistics.

#### **14- RESEARCH THESIS**

A research thesis (dissertation) of about 20 thousand words is required. Topics are agreed with prospective supervisors. Generally, the research exercise amounts to an investigation in one of the areas outlined in the program course plan.

The thesis is based on original work by the student and should meet the academic standards explicitly expressed in the King Faisal University regulations.

# 15- BENCHMARKS AND QUALITY ASSURANCE STANDARDS

The need for reinforcing standards and abiding by explicit evaluation and benchmarks is paramount. In this respect, the M.A. program described here is not an exception. Therefore, it is essential for the providing department, the Department of English Language, to uphold the following benchmarks to ensure the quality of the learning experience the program stands to offer.

#### **Benchmarks:**

#### 1- Admission Requirements outlined in (8) above:

- A. General Point Average of Very Good in the B.A.
- B. A set of prerequisite courses for candidates who do not come from an English language/Linguistics background.
- C. One of the following tests:
  - a. TOEFL: achieving a score of 75 out 120, with a writing component (Taken within at most two years prior to the date of M.A. screening by the DEL), in addition to a problem solving question in research methodology.
  - b. IELTS: achieving a score of 5.5 out of 9, with a writing component (Taken within at most two years prior to the date of M.A. screening by the DEL), in addition to a problem solving question in research methodology.
  - Department admission test: achieving a score of 70 out of 100, including a writing component), in addition to a problem solving question in research methodology

#### 2- Course passing requirement:

a. 70% is the minimum required score for passing any of the courses.

#### 3- Entry to comprehensive examination requirement:

a. A total of very good General Point Average.

### 4- Thesis proposal:

a. Preparation and completion of a thesis proposal which has to be discussed and approved by the department. The proposal is later approved by the College Council and the Higher Studies Council of the Deanship of Higher Studies.

### 5- The thesis Examination (Viva Voce)

a. The thesis is examined in an open session (viva voce) in accordance with KFU regulations.

#### **C- Course prerequisites**

M.A. candidates should study the Program Prerequisites (listed above under Admission Requirements) before starting courses from the M.A. program. However, according to Item 12 of the *United Regulations of Graduate studies in Saudi Universities*, the department is allowed to permit candidates to take up to two prerequisites at the same time they studying the core courses.

There is no strict ordering of the courses in the program, but the following guidelines are to be observed.

- 1- "Methodology of Linguistic Research" should be offered in the first semester.
- 2- Core courses are offered before elective courses.
