Further to our circulation No. 2S 4526 on: 24-12-1432 Hijri, Based on the circulation of His Royal Highness the prince of eastern province, No. 12 S 8664 on: 14-11-1432 Hijri, we received a copy of the letter of His Excellency the deputy of the principality of the eastern province, No. 30525 on: 21-06-1433 Hijri, addressed to H.E. the Director general of the education office at the eastern province stating as follows: “ Reference to your attached letter No. 33957333 on: 07-06-1433 Hijri, combined with the letter of the chairman of the management council of the Turkish international school in El-Dammam, (without number) on: 29-05-1433 Hijri, including a request for permitting the Turkish embassy staff to visit the Turkish international school to perform their official duties and settle the works of the Turkish residents who live in El-

Dammam and its surroundings on Thursday and Friday 10-07-1433 and 11-07-1433 Hijri, provided that they will comply with your conditions and regulations and that you do not mind giving your consent to that, although the approval of the ministry of Foreign Affairs is still under processing.

As there was a previous circulation issued by His Royal Highness, the prince of the eastern province, No. 12S 8664 on: 14-11-1432 Hijri, Based on the circulation No. 68203 on: 29-10-1432 Hijri, of His Royal Highness, the second Deputy of the Prime Minister and Minister of the Interior, in which His Highness has mentioned that he received Royal Decree No. 4987/MB on: 03-08-1433 Hijri, Which was addressed to him and to His Royal Highness the Minister of Foreign Affairs directing the governmental agencies that they must neither address nor approve meetings with foreign representatives before the previous coordination of these representatives with the ministry of Foreign Affairs. This must strictly be complied with and the necessary action will be taken against the laxity of any governmental agencies. We would like you to complete the required thereunder. (Text is over).
